# Acknowledgements

# **ground**

ealth Partners, L.L.C. has been an APPEAL (Asia-Pacific Partners for Leadership, Advocacy and Empowerment) technical assistance and training consortium regional partner for Guam since 2007. Previous to this current grant, and with the support provided by AP-

PEAL, Health Partners, L.L.C. was able to mobilize an inter-sectoral, multi-agency group to develop an island-wide strategic action plan to combat the tobacco epidemic on Guam.

Working in partnership with community members and institutional stakeholders in tobacco control and using an incremental and participatory approach, from 2007-2009, Health Partners, L.L.C. conducted a community opinion leaders survey and convened a community workshop to gauge Guam's readiness for tobacco control. At the community workshop, participants developed a common

vision and strategic directions for tobacco control to guide Guam's efforts. In the second year of the grant, community stakeholders re-convened to develop an integrated strategic plan for tobacco control, based on the recommendations from Year 1. (Please refer to the previous publica-



tions by Health Partners, L.L.C. detailing the process and outcome of the community readiness

survey and the tobacco control strategic plan.)

Under the current APPEAL PROMISE network grant, Health Partners, L.L.C. continued to build on the work from previous years,

and pursued key strategic actions outlined in Guam's strategic plan for tobacco control. This progress report documents the achievements thus far in meeting the objectives and action steps under the current grant.

#### **AN OVERVIEW OF PROGRESS**

This APPEAL grant built on the work and progress achieved from the previous 2 years that Health Partners, L.L.C. has served as the AP-PEAL Technical Assistance and Training Consortium Regional Partner for Guam.

> It continued to provide the opportunity to bridge a critical gap in Guam's tobacco control work. By channeling resources through a local private sector organization, it facilitated bringing together community stakeholders to mobilize support and provide the evidence for raising tobacco taxes and earmarking tobacco tax revenues for tobacco and cancer pre-

vention and control. This policy intervention--raising tobacco taxeswas identified as the key policy priority in the consolidated Guam Tobacco Control Strategic Plan developed under Year 2 of the previous APPEAL grant.

The grant enabled Health Partners to facilitate better ethnic balance in coalition representation. The grant also afforded additional technical assistance, sourced locally, to strengthen the island's current tobacco control capacity for cessation and to provide a model for some of the neighboring Pacific islands in their tobacco control work.





## Activities and PROGRESS ACHIEVED

Providing the evidence and mobilizing community support for increasing tobacco taxes

he most significant, and critical. achievement was the successful provision of technical assistance and advocacy assistance to the Guam Cancer Control Coalition, leading to an increase in Guam's tobacco tax rates and the earmarking of tax revenues for tobacco and cancer prevention and control. Health Partners, L.L.C. was one of a select group of cancer control coalition institutional members that worked closely with coalition members and policy leaders throughout the process of mobilizing support through local and global data and evidence for raising tobacco taxes.

Specifically, Health Partners, L.L.C. facilitated the creation of critical fact sheets which were supplied to policy makers, key decision makers and

The most significant progress achieved thus far under this grant is the successful provision of local data and evidence to community leaders to increase tobacco taxes and earmark tobacco tax revenues for tobacco and cancer control and prevention.

As a result, Guam passed a law that increased tobacco taxes by \$2.00/pack, with the revenues channeled to the Healthy Futures Fund, which shall support tobacco and can-

# Empowering THE COMMUNITY

### to determine Guam's strategic priorities for tobacco control

ealth Partners, L.L.C. assisted the Guam Cancer Control Coalition in identifying and inviting key community opinion leaders from Chamorro and other Micronesian groups into the Guam Cancer Control Coalition. On April 7, 2010, Health Partners, L.L.C. hosted a Tobacco Control Strategic Planning

Community Workshop at the Hilton Resort and Spa, Tumon, Guam. The workshop brought together a diverse group of tobacco control community stakeholders from both private and public sectors to:

Assess progress made against the objectives of the Guam Tobacco Control Strategic Plan (developed by community stakeholders during an APPEAL-funded community workshop



#### in 2008);

Re-assess Guam's stage of community readiness using the APPEAL Tobacco Control Community Readiness model; and,

Defined key strategic actions for 2010.

A total of 37 participants attended the workshop, comprised of 24 Chamorros, 10 Filipinos, 2 Caucasians and 1 Palauan. Participants worked in 4 subgroups: Policy, Programs, Partnerships and Research and Data.

Towards the end of the workshop,

participants were asked if they were interested in having their organizations join the APPEAL National Network. Twenty-four of the 37 participants signed up and declared their interest in joining APPEAL. Seven of these participants also indicated their willingness to join the tobacco

control coalition and/or a community tobacco control advisory group.

# Expanding CESSATION CAPACITY

### within the Pacific Region

By leveraging other resources and opportunities, Health Partners, L.L.C. was able to augment the capacity and experience of the current group of Chamorro and Filipino BTI (Brief Tobacco Intervention) trainers in delivering BTI training to other Micronesian audiences and to assess the efficacy of Guam BTI training curriculum among other Pacific Islander communities. Health Partners, L.L.C. also used a portion of the APPEAL grant funding to host a BTI Training workshop for Chamorro and other Micronesian community members on May 8, 2010 at the Outrigger Resort and Spa, Tumon, Guam.

### **ACTIVITY 1:** Evaluating the Guam BTI Training Curriculum among Micronesian Audiences

In 2009, the South Pacific Office of WHO requested Health Partners, L.L.C. to deliver BTI Training to 4 Pacific Island communities in the Commonwealth of the Northern Mariana Islands (CNMI), the Federated States of Micronesia (FSM), the Republic of Palau, and the Republic of the Marshall Islands. Health Partners, L.L.C. recognized this as an opportunity to hone the experience of Guam's current group of BTI trainers, composed of Chamorros and Filipinos, in delivering BTI training to other Micronesian audiences. We also saw an opportunity to evaluate the Guam BTI training curriculum with regards to its applicability, cultural competence and efficacy among other Micronesian participants. The APPEAL PROMISE Network grant supported the time for Dr. Annette David and Ms. Roxy Mad, project assistant, to do a systematic assessment/evaluation of the BTI trainings conducted in the 4 Pacific Island communities. The result of this assessment is a report, "Integrated Evaluation of BTI Training among 4 Pacific Islands, 2009," which was submitted to WHO and shared with APPEAL, Guam DPHSS and DMHSA. The lessons learned from this evaluation will be presented at the 10<sup>th</sup> Asia-Pacific Conference on Tobacco or Health, October, 2010 in Australia.

### ACTIVITY 2: Community BTI Training Workshop

Once tobacco taxes are increased, we anticipate an increased demand in cessation services, particularly among Chamorro and Micronesian tobacco users, who tend to be from the lower socio-economic groups, and hence, most susceptible to tobacco price increases. On May 8, 2010, Health Partners, L.L.C. conducted a training workshop for community members in BTI, to augment the current capacity for cessation services.

Twenty participants attended the workshop, 16 (80%) of whom successfully completed all of the requirements for certification in BTI. The workshop was conducted in partnership with Guam DPHSS, Guam DMHSA and the PEACE project. Included among the participants were 4 youth (aged

15, 16, 17, and 25). The ethnic breakdown of the par-



- ticipants was:
- 35% Chamorro
- 30% Filipino
- 30% Other Micronesians (1 Palauan, 3 Pohnpeian and 2 Chuukese)
- 5% American Indian.

The following graph demonstrates the change in preand post-training confidence levels for delivering brief

cessation advice among the participants. Participants were asked to rate their confidence in accomplishing 8 specific BTI skills before and after completing the training workshop, on a scale of 1 ("No confidence) to 5 ("Very confident"). There was a statistically significant increase in reported confidence after completion of the training.



# Final Word

The activities and outcomes achieved under this project would not have been possible without the participatory approach and partnerships that the project has fostered. Building on the networks of stakeholders established by the previous APPEAL grant, this project demonstrates the power of community partnerships and the value of leveraging technical expertise, resources and creative ideas across the various institutional and individual members of the coalition when focused on clear goals.

With the support provided by grants such as the APPEAL Promise Network, Guam is moving along the path towards a healthier, tobacco-free future.
